The Committee will meet again early in the New Year. When it does so, it will take a number of decisions which will affect us all. I shall detail the main items hereunder for your information, and, hopefully, to get some feedback as to whether you approve of our plans, or not!

The most important matter concerns the club general meetings, which, as you know, are held on the third Saturday of every month except December, at 13.00 hrs (the Committee meets at 12.00 hrs.)
